

# **Housing Navigator**

# **Description of Position**

Strafford Regional Planning Commission (SRPC) seeks a full-time housing navigator to join its team of hardworking, motivated individuals dedicated to providing the highest quality of public service in a friendly, progressive environment. SRPC's staff work as an innovative and collaborative team focused on supporting our 18-member communities.

The housing navigator will work closely with, and under the supervision of, the Towns of Farmington and New Durham to address housing challenges and opportunities. The navigator will engage community members, build partnerships and community support, provide technical assistance to land use boards, staff, and applicants, perform land use application reviews, assist with implementation of local planning initiatives, and conduct an audit of local regulations.

The successful candidate will have strong community engagement and education skills, be able to build consensus around specific housing policies or planning projects, and familiarity with local land use planning and development processes.

# Responsibilities

Community Engagement:

- Participate in and recruit local champions to attend the UNH Cooperative Extension Housing Academy.
- Work with local staff and volunteer partners to design and implement a community
  engagement plan to include an initial public forum, a series of speaker presentations,
  housing discussions with local employers, and creation of educational resources.
- Engage with leaders in the housing community to support the development of best approaches to achieve the housing goals of the two communities.
- Engage with local employers and others from the business community about the impact of the housing crisis on their ability to recruit and retain workers.
- Engage with members of the community, to build awareness of matters related to housing and the impacts that it has on the health and vitality of their community, while ensuring their voices are acknowledged during regulatory change processes.

### Planning and Development Processes:

- Provide direct land use support and assistance to residents and applicants seeking approvals that will lead to the development of new residential units.
- Work directly with housing developers, property owners, and housing coalitions for the purpose of facilitating specific developments.
- Assist both developers/businesses/applicants and local boards with proposals and the application review process.
- Attend evening meetings to provide technical assistance to local land use boards.
- Act as a liaison between the technical review committees and boards.

- Assist with economic development initiatives that support new housing opportunities.
- Write grant applications or proposals to further housing goals.
- Strengthen the capacity of existing staff to move applications and planning initiatives forward in a timely fashion.
- Provide direct staff support to programs that have the potential to increase redevelopment for housing and economic development.
- Perform an audit of the local regulatory framework to identify provisions where barriers may be removed, or new opportunities created to support housing development.
